International Political Environment- Very big problems

Massive disruptions coming globally....

- "Settling of scores" -wars, refugees, anti-immigration trends
- Civil wars- questioning of democratic values- mistrust in business, government and media elites – inequality continues to rise
- Is globalization dead? Pandemic, climate emergency
- Trade a weapon- oil, grain, strategic minerals, etc.
- Energy security vs. environmental stewardship and climate emergency
- Financial instability- U.K. pension funds, higher volatility, complexity of regulation, and financial instruments (AIMCo's VOLTS strategy), central bank tightening
- Infrastructure vulnerability cyber-security, "terrorism," complexity (Rogers)






Alberta Political Environment- Technology Is this the Silver Bullet for climate emergency? Nuclear

Small nuclear reactor- when?




Alberta Political Environment- Technology Is this the Silver Bullet for climate emergency? CCUS

Carbon capture and Underground storage-Economic? Safe? When? Who pays?




Political Environment- Technology Is this the Silver Bullet for climate emergency? Blue Hydrogen




The Alberta economy in 3-5 years- Energy Bitumen- our future?




The Alberta economy in 3-5 years- Energy Conventional oil- not much happening




The Alberta economy in 3-5 years- Energy Natural Gas- LNG may be imperative



NDP Resolutions on Housing-municipalities

- Alberta NDP supports providing appropriate levels of funding for Municipal Housing projects for vulnerable Albertans, including maintenance and operational costs for the residences and services that residents will need; and
- the Alberta NDP supports developing appropriate regulations to ensure that funds for these projects are spent only on facilities, maintenance, and support programs;

Resolutions on Housing-climate change

- Sets explicit carbon emissions limits in building codes for new and existing buildings and adopt heating equipment standards requiring low-carbon emission systems; and
- Change building codes to increase the durability of building materials to double the expected service life; and
- Establishes targets to include locally sourced, recycled, sustainably produced, or reused materials in construction where possible, and for using construction materials that can be recycled or have a lowenvironmental impact at disposal at end of life; and,
- Includes universal design best practices to design, build, and manage buildings currently regulated by the Code.

Implications for RECA- Legislation

- Little substantive legislation before election
- Self-regulation likely remain even under NDP government
- Revenue pressures raising licensee fees
- Self service licensing through IT innovation
- Greater attention to social housing and rentals if NDP wins
