You may ask for a review under Part 5 of the FOIP Act by the Information and Privacy Commissioner (Commissioner). To request a review, you must submit a completed Request for Review form within 60 days from the date of this letter to the Commissioner at Suite 410, 9925 – 109 Street, Edmonton, Alberta, T5K 2J8.
